I. Case Summary

This is a case about a mistaken identification that resulted in an innocent man—Mr. Joseph Webster—being convicted of a murder that he did not commit. The one and only witness who has ever identified Mr. Webster as the perpetrator of this murder has since recanted her prior testimony under oath three (3) separate times. Even at Mr. Webster's trial, however—which occurred nearly eight years after the murder took place—this lone eyewitness's identification of Mr. Webster suffered from serious inaccuracies, gross inconsistencies, and myriad credibility concerns that suggest it was mistaken. Importantly, after Mr. Webster was convicted, three members of his family also came forward and testified that his <u>brother</u>—who resembles Mr. Webster—had privately confessed to them that he was the real killer. Crucially, no direct evidence has ever connected Mr. Webster to this crime, and he has steadfastly maintained his innocence for nineteen years. Of special significance, a vast amount of evidence gathered from the crime scene—including the murder weapon—also has never before been tested for DNA.

Regrettably, any neutral evaluation of Mr. Webster's case also compels the conclusion that the investigation into Leroy Owens's murder was seriously deficient. For example, a second apparent eyewitness to the murder—Ms. Lakeeta Smith—was seemingly never asked to attempt an identification. The perpetrators' pager number—which could have proven conclusively who the killer was—also was never determined, even though multiple witnesses stated that the perpetrators had given it to them. It is also undisputed that there were two perpetrators involved in Mr. Owens' murder, but the identity of the second perpetrator still remains unknown. Perhaps most importantly, however, neither the murder weapon, nor a cigarette pack that was found at the crime scene, nor the victim's shirt with visible blood stains on it has ever been tested for DNA.

Significantly, the second person involved in the murder of Leroy Owens also has never been identified. Thus, even if the accuracy of Mr. Webster's conviction were not plagued by such serious doubt, the fact that Mr. Owens' murder remains a cold case as to his second killer provides an independent basis for reopening this investigation. Based on the profound uncertainty about the accuracy of his conviction, however, Mr. Webster requests—at a minimum—the following:

- 1. That this office conduct a Y-STR forensic DNA analysis of the murder weapon, the cigarette pack found at the scene, and the victim's "white shirt with some blood" on it, none of which have ever been tested for DNA;
- 2. That this office re-interview Lakeeta Smith—a second eyewitness to the crime who was never asked to make an identification—for the purpose of having her attempt to identify Mr. Owens's killers; and
- 3. That this office re-interview Tammy Nelson for the purpose of evaluating whether her original identifications of Mr. Webster or her subsequent identifications of Mr. Webster's brother are more reliable.

II. Case History

A. Summary of Murder

On November 22, 1998, Leroy Owens was murdered by two African American males. The two perpetrators assaulted Mr. Owens outside Tammy Nelson's apartment, chased him down the street, and ultimately killed him by striking him in the head with a cinder block. The apparent motive for the murder was that Mr. Owens owed the perpetrators money from a prior drug sale.

Prior to the murder, the two perpetrators came around Tammy Nelson's apartment in search of Mr. Owens "about five or six times." 4 Ms. Nelson and Mr. Owens were friends,

and they did drugs together.⁵ The perpetrators stated that they were Mr. Owens' "cousins," but they apparently did not tell Ms. Nelson why they were looking for him.⁶ The perpetrators also left their pager number with Ms. Nelson and other individuals in the area with instructions to page them if Mr. Owens ever came back around.⁷

On November 21, 1998, Mr. Owens returned to Ms. Nelson's apartment. Thereafter—either that evening or the following morning (it is not clear which, because Ms. Nelson gave conflicting statements on the matter⁸)—Ms. Nelson paged the perpetrators to alert them that Mr. Owens had returned.⁹ Shortly after 11:00 a.m. on November 22, 1998, the perpetrators arrived at Ms. Nelson's unit and asked to see Mr. Owens. After Mr. Owens came outside to meet them, the perpetrators assaulted him in view of Ms. Nelson¹⁰ using a stick that they had either brought with them or that they took from Ms. Nelson herself.¹¹ At least one other eyewitness—Ms. Lakeeta Smith—witnessed this initial assault as well.¹²

After Mr. Owens was assaulted outside Tammy Nelson's house, he attempted to escape by running away. Mr. Owens initially did escape by running inside a house owned by Mr. Delunn Hyde.¹³ Mr. Hyde told Mr. Owens that he wanted no part of whatever was going on, however, so he instructed Mr. Owens to leave.¹⁴ Mr. Hyde then escorted Mr.

Owens out of his house. After Mr. Owens exited Mr. Hyde's house, the perpetrators' white, souped-up station wagon came speeding down the street in pursuit of him. Mr. Hyde was only able to identify the occupants of the vehicle as two black males, and thus, he could not make an identification. After Mr.

After running Mr. Owens down in their white station wagon, the perpetrators "bum rushed" Mr. Owens, knocking him into a construction worker named Fred McClain. Mr. McClain then ran around the side of a nearby building, but he witnessed the events that followed.¹⁷ According to Mr. McClain's testimony, the perpetrators knocked Mr. Owens down, and one of them began striking him in the head with a concrete cinder block.¹⁸ The perpetrator with the cinder block also stated: "Where's my money? Where's my goddamn money?"¹⁹ Mr. McClain was shown a photo lineup containing Mr. Webster shortly thereafter,²⁰ but he was unable to make an identification, either.²¹

Mr. Owens' death was ruled a homicide. The coroner concluded that his death was caused by the blunt force trauma of multiple cinder block strikes to the head. The coroner also observed several defensive wounds on Mr. Owens' hands,²² suggesting that a struggle had taken place.

The cinder block that was used to kill Mr. Owens was retrieved from the crime scene. To this day, it remains covered in blood. Investigators also retrieved an empty pack of Salem cigarettes from the scene that may or may not have belonged to the

perpetrators as well,²³ and they recovered the victim's "white shirt with some blood on [it]."²⁴ None of these items has ever been tested for DNA.

B. Identification of Joseph Webster

No direct evidence has ever connected Mr. Webster to Mr. Owens' murder, and at trial, Mr. Webster's defense was mistaken identity. Neither Mr. Hyde nor Mr. McClain was able to identify the perpetrators involved. Additionally, eyewitness Lakeeta Smith was never even asked to make an identification.²⁵

Instead, Tammy Nelson—the crack cocaine addict who paged the perpetrators to let them know that Mr. Owens had returned to her apartment—provided the only identification that has ever been made in this case. Ms. Nelson identified Joseph Webster as having been one of the perpetrators involved in Mr. Owens' death after being shown a six-pack photo lineup provided by Detective Pat Postiglione. Ms. Nelson also stated that she had seen the individuals she selected up close "[a]bout five or six times" prior to the murder. She further stated that she had always seen these individuals in the "afternoon" and in the "daylight," with sufficient lighting that she "could actually see [their] face[s], "29 and that there was never anything covering their faces. 30

Mr. Webster was arrested and convicted for the murder of Mr. Owens almost entirely on the strength of Ms. Nelson's identification nearly eight years later.³¹ Because

no additional evidence was gathered in the interim, however, it is not clear what accounted for the delay.

III. Three Family Members Come Forward and Testify that Mr. Webster's Brother Kenneth Neal Confessed to Killing Mr. Owens

Immediately after Mr. Webster was convicted at trial, three separate family members—Mr. Webster's mother, Marie Burns; his brother, Arthur Gordon; and his wife, Katrina Webster—came forward and signed sworn affidavits attesting that Mr. Webster's brother had privately confessed to being the real perpetrator.³² These witnesses also provided sworn testimony as to the facts set forth in their affidavits during Mr. Webster's motion for a new trial.

In pertinent part, Ms. Burns swore that:

"My son, Kenneth Neal, told me that he committed this murder, but not to worry about it, as he had taken care of the problem and he felt that they could not prove that Joseph committed any murder. He also told me that him and Phillip Cotton had taken the white station wagon to the country to be destroyed."33

Similarly, Mr. Gordon swore that:

"My brother, Kenneth Neal, talked to me about the murder in this case, a short time after the incident actually happened.

Kenneth Neal admitted to me that he killed a man by hitting him with a brick. He told me this at his house, which at that time was off of Murfreesboro Road on Plus Park Blvd. It turns out that this is only a matter of minutes from where the crime took place.

He told me this after I had inquired about where his white station wagon had been. He then told me that he got rid of his white station wagon somewhere out of town.

He also stated that he did not intend to kill the man."34

Finally, Ms. Webster swore that:

"Once Joseph was indicted in this matter, Kenneth and I got into an argument because I told him that Joseph was in trouble for his charge. He got mad and stated that, 'I needed to stay out of his business." 35

IV. Serious Concerns about the Reliability of Ms. Nelson's Identification

By all accounts, despite being a self-described crack cocaine addict,³⁶ Ms. Nelson made a strong trial witness. At trial, she also gave the appearance that she was certain that her identification was accurate,³⁷ despite previously stating that she "really couldn't identify [the perpetrators] back then" and "just picked out a mug shot of guys that looked like them."³⁸ Even before she came forward and recanted her trial testimony under oath three separate times, though, any neutral analysis of her initial identification of Mr. Webster reveals that it suffered from several significant and fatal flaws. Compounding these concerns, Ms. Nelson also lied repeatedly about multiple facets of this case, she was not a remotely trustworthy witness at any point, and she may well have been involved in the crime hereself. In fact, one witness (who did not testify) told Detective Postiglione that "the victim was killed after he was set up by Tammy."³⁹ A non-exhaustive list of concerns about the reliability of Ms. Nelson's identification appears below.

A. A glass or plastic eye that "goes up" and no gold teeth.

Ms. Nelson's recollection of the perpetrator's distinguishing facial features was both provably and materially inaccurate. First, she testified that the perpetrator had a distinguishing feature that Mr. Webster most certainly does not—an eye deformity that caused one of his eyes to "go up," which may have been attributable to "glass or plastic or something on his eye."⁴⁰ Mr. Webster does not have any eye deformity, and he most certainly does not have a glass or plastic eye.

Most importantly, though, Tammy Nelson stated unequivocally that Mr. Webster did not have gold teeth, and she further stated that she would "sure remember gold" if he did.⁴¹ She also never mentioned gold teeth at any point throughout the investigation to anyone involved in it. Ms. Nelson also stuck to this description at trial by identifying only one of the perpetrator's eyes as having been a memorable facial feature—making no mention of gold teeth whatsoever.⁴² Crucially, however, long before the murder took place, Mr. Webster had twelve extraordinarily prominent, bright yellow gold teeth permanently implanted that looked like—and still look like—this:

B. Serious conflicts between Ms. Nelson's own prior statements and her trial statements, and additional conflicts with other witnesses' accounts.

In addition to conflicting with several other witnesses' accounts, Ms. Nelson's trial testimony also differed materially from her own prior statements in several respects. In some cases, it is not clear whether these inconsistencies were mere memory lapses or innocent mistakes. In other cases, however, it is clear that Ms. Nelson either lied before trial or that she lied during trial.

Most significantly, just before Mr. Webster's trial, Ms. Nelson stated the following during a recorded interview with Mr. Webster's investigator—former MNPD officer Bob Lyons:

Lyons: "[H]ad these two people [that you identified] walked in right now and you looked at 'em, could you identify these people if you wanted to?

Nelson: "No."

Lyons: "It's been that long?"

Nelson: "I couldn't identify them. I really couldn't identify them back then."

Lyons: "You couldn't identify them back then, is that what you said?"

Nelson: "I really couldn't identify them back then. I just picked out a mug shot of guys that looked like them. I don't know. Just big guys, big black guys."43

Ms. Nelson further stated: "[The police] showed me some mug shots and it was two fat boys that I picked out. I don't know the guys. I couldn't be accurate on it."44

Just a short time later, however, during Mr. Webster's trial itself, Ms. Nelson's recollection changed dramatically, and she testified that her identification was and had always been ironclad. On direct examination, Ms. Nelson was asked if she had "any doubt whatsoever that the person" she picked out was the defendant sitting in the courtroom. Ms. Nelson answered: "I know that's the person. That's the person I picked out. He still looks the same right [here] today." Ms. She further testified: "I told [Detective Postiglione] when I picked out number five, Joseph Webster, that I knowed that was him. And then the other guy that I picked out I was sure, for sure that was the other guy that was with him." Of note, it is not clear from the record who "the other guy" that Ms. Nelson identified was, and no other individual has ever been charged in connection with this case.

Other discrepancies were similarly deliberate. For example, when asked if she had witnessed the initial assault that took place at her apartment before the murder, Ms. Nelson told Mr. Webster's investigator that "didn't see any assault" and "didn't see nothing. None of that."⁴⁸ She also said that she hadn't witnessed any "yelling or screaming."⁴⁹ At trial, however, Ms. Nelson offered a vivid and detailed account of her personal recollection of the initial assault, and she even claimed to have tried to intervene to stop it.⁵⁰

There are also several details of Ms. Nelson's account that conflict with the testimony of other witnesses who were interviewed by detectives in this case. For instance, when describing the initial assault that took place, Ms. Nelson testified that Mr.

Webster "had a stick in his hand" when he initially approached the victim.⁵¹ However, Lakeeta Smith—a second eyewitness who was not called at trial—gave a markedly different account. In her interview with Detective Postiglione, Ms. Smith stated that the perpetrators "took a stick *out of Tammy's hand* and hit the victim with it"⁵²—suggesting that Ms. Nelson may herself have been involved in the perpetration of the crime. This theory was also supported by Jeffery Bigsby—another witness who did not testify at trial—who stated that the victim was killed "after he was set up by Tammy."⁵³

Other discrepancies may well have been innocent, but still demonstrate Ms. Nelson's unreliability. For example, Ms. Nelson testified at trial that she "paged [the perpetrators] that day, the same day that [Mr. Owens] got killed," and she further specified that she paged them "that morning." 54 She also testified that the victim "was asleep" at her house at the time she paged the perpetrators, and that she "went and woke [him] up" after she paged them. In sharp contrast, however, during her recorded interview with Mr. Webster's investigator, Ms. Nelson stated that she "didn't call 'em that morning," that the perpetrators arrived "the next morning" after she paged them, and that the victim was not "at [her] house at the time [she] called them." 55 Ms. Nelson also stated both that she had "sold drugs in the past" 56 and that she "ain't never selled no dope." 57 These statements simply cannot be reconciled with one another, and they, too, seriously undermine Ms. Nelson's credibility.

C. Ms. Nelson concealed her involvement in the victim's murder and actively obstructed the investigation into it.

Ms. Nelson's credibility was also subject to serious doubt because she deliberately concealed her involvement in Mr. Owens' death for seven-and-a-half months after his murder and actively obstructed the investigation into it. As indicated previously, Ms. Nelson herself was personally responsible for paging the perpetrators before they came to murder Mr. Owens⁵⁸—something that could reasonably cause someone to question whether she had been involved in it herself. Of special note, the pager number that Ms. Nelson used to reach the perpetrators could also have been traced to its owner and definitively identified Mr. Owens' killer if the number had been given to detectives to trace. This lead was never effectively pursued, however, because Ms. Nelson successfully obstructed the investigation into Mr. Owens' death by concealing her involvement in his murder and destroying evidence related to it.

First, despite giving multiple interviews about Mr. Owens' slaying, Ms. Nelson failed to mention either that she was in possession of the perpetrators' pager number or that she had been the one who paged them until fully "seven and a half months after the fact" 59—and only then after being confronted with evidence on this point gleaned from another source. 60 In fact, when first interviewed by Detective Postiglione, Ms. Nelson "denied any knowledge of even knowing the victim initially." 61 Ms. Nelson did not come clean about the pager until after Detective Postiglione "told her that [he] had information she was involved in this." 62

According to Detective Postiglione himself, Ms. Nelson's failure to come forward with the fact that she had paged the perpetrators until seven-and-a-half-months after the

fact also materially undermined the investigation into Mr. Owens' murder. After Ms. Nelson finally came clean about having paged the perpetrators, for example, Detective Postiglione testified that the investigating officers returned to the complex where Ms. Nelson had lived in the hopes of tracing the phone call that she made to the perpetrators' pager. Upon doing so, however, Detective Postiglione stated that:

"When we went back to check there was no way to go back and just check the phone numbers. Otherwise, clearly that would have been something for obvious reasons we would have been interested in....[W]e went back to those particular addresses and most of them were actually boarded up when we went back there in 1999."63

The fact that Ms. Nelson's outgoing phone call was no longer traceable would not have been so significant if the records from the pager itself had been traced, however. Significantly, though, <u>Ms. Nelson also tore up the piece of paper containing the perpetrator's pager number, preventing detectives from tracing it.</u>⁶⁴ Ms. Nelson alternately attempted to explain her behavior at trial by testifying: (1) that she "didn't know it was evidence" when she tore it up,⁶⁵ (2) that she tore it up because she "was scared back then,"⁶⁶ and (3) that, perhaps, she actually didn't tear it up after all. ⁶⁷ "That's what I told him [referring to Detective Postiglione]. But I can't remember [if I tore it up or not]," she stated. ⁶⁸

It goes without saying that these nakedly self-serving and mutually conflicting explanations for having destroyed potentially outcome-determinative evidence cannot be

deemed credible—especially in light of the fact that Ms. Nelson deliberately misled detectives about having paged the perpetrators in the first place.⁶⁹

D. Ms. Nelson's Three Sworn Recantations

A further, equally serious reason to doubt the accuracy of Ms. Nelson's identification is that she has recanted it three separate times—all under oath—since Mr. Webster was convicted. In two of those instances, she has also identified Mr. Webster's brother as the actual perpetrator.

First, on January 21st, 2009, Ms. Nelson handwrote, swore to, and signed the following statement in her own words:

"January 21, 2009

I Tammi Terrell Nelson is writing this statement to let the state know that I was mistaken identified Joseph Webster as his brother Kenny Neal in court and its been weighing heavly on my heart to where I've been put on medication for stress and having terrible dreams. I'm a 39 yr old mother with 2 grandchildren. During the time of this trial I was pressure into testified because of my addiction therefore this is my written statement.

Tammi Nelson 1-21-2009"⁷⁰

Second, on February 7th, 2014, Ms. Nelson swore to and signed the following typewritten statement, which had been prepared for her after she provided an oral statement to a notary:

"I Tammie Terrell Nelson, being of sound mind and body, and under no threat of bodily harm, do hereby make and sign the following affidavit under penalty of perjury:

In March of 2006 I falsely testified for the state of Tennessee in the murder trial of Joseph D. Webster. At the time of the trial, I was serving time on charges of drug possession, prostitution, and violation of probation. I was also addicted to crack cocaine. Taking advantage of my addiction and desire to get out of jail, district attorney Pamela Anderson offered me a deal to testify against Mr. Webster and help to secure his conviction. In return, I would be sentenced to Davidson County Drug Court instead of prison; upon my completion of this program I would be returned to the streets. I agreed to this deal and it has haunted my conscience since. The truth of the matter is that I DID NOT witness Joseph D. Webster harm anyone and I only said so because of the deal placed before me. And let me be clear by stating that this deal WAS in place long before Mr. Webster's trial.

Again, I am not under duress whatsoever nor have I been threatened by anyone to sign this affidavit nor have I been offered any monetary gains or anything otherwise. My conscience has been eating away at me and this is just the right thing to do. Mr. Webster is innocent of the crime that he is in prison for, and I need to right this wrong that I helped to cause. I pray that this helps. Thank you.

Tammy Terrell Nelson"71

Third, providing in-court testimony on October 10, 2014, Ms. Nelson testified repeatedly that she had wrongly identified Mr. Webster as the perpetrator, and she further testified that she realized that she had made the error after seeing a photo of Mr. Webster's brother for the first time. For example, after being asked why she was sure her identification of Mr. Webster was mistaken, Ms. Nelson testified:

"The reason, I saw a picture of—a picture of another person, his brother. And I was like – you know, when I saw the picture, I just broke down crying because I thought all these years, and then about me being in my right mind and not on the drugs like I used to be on that had me all confused. And I know now that it wasn't – it wasn't Joseph."72

E. Ms. Nelson's inconsistent statements under oath about receiving a deal in exchange for testifying against Joseph Webster.

Ms. Nelson has also given multiple conflicting statements under oath about having received a deal in this case in exchange for her testimony, which also significantly undermines her credibility. Of note, if such a deal existed, it has never been disclosed to the defense, and the prosecution would have been constitutionally obligated to disclose it.

"Taking advantage of my addiction and desire to get out of jail, district attorney Pamela Anderson offered me a deal to testify against Mr. Webster and help to secure his conviction. In return, I would be sentenced to Davidson County Drug Court instead of prison; upon my completion of this program I would be returned to the streets. I agreed to this deal and it has haunted my conscience since. The truth of the matter is that I DID NOT witness Joseph D. Webster harm anyone and I only said so because of the deal placed before me. And let me be clear by stating that this deal WAS in place long before Mr. Webster's trial."75

While testifying during Mr. Webster's coram nobis proceeding in October 10, 2014, however, Ms. Nelson then reverted back to her original position. Specifically, she stated

that she did <u>not</u> expect any favorable treatment for testifying against Mr. Webster,⁷⁶ that she signed her February 2014 statement "not knowing that [she] was signing it,"⁷⁷ and that the statement she gave orally to the notary was "totally different" from the one that she signed that day.⁷⁸ Ms. Nelson further testified that she "never saw this woman [District Attorney Pamela Anderson] a day in my life."⁷⁹

Pamela Anderson was, of course, the lead District Attorney on the Webster case. In that capacity, she cross examined Ms. Nelson for approximately two hours during Mr. Webster's trial, so Ms. Nelson certainly had seen her before. Consequently, like Ms. Nelson's other statements and inconsistent testimony throughout this case, it is never quite clear if she is lying or if her memory is just extraordinarily unreliable as a consequence of her decade-long addiction to crack cocaine.

For what it's worth, Ms. Nelson did avoid jail time and was placed in community corrections after testifying against Joseph Webster.⁸¹ Other than her sworn statements on January 21, 2009 and February 7, 2014 that she was pressured into testifying by the State and received a deal in exchange for her testimony, however—statements that, as noted, Ms. Nelson also repudiated under oath both before and after giving them—there is no indication that Ms. Nelson avoided jail time *in exchange* for her testimony.

V. Opportunities for Further Investigation

A. Y-STR DNA Testing

Neither the murder weapon (the cinder block), nor fragments of it recovered from the crime scene, nor an empty cigarette pack found at the crime scene, nor the victim's blood-stained white shirt has ever been tested for DNA evidence. This omission is also especially significant in light of several defensive wounds found on the victim's hands⁸² that indicate the possibility that the victim may have drawn his perpetrators' blood during their confrontation. Of note, at Mr. Webster's trial, Detective Wayne Hughes also testified that "the blood stains [would] possibly be good evidence." In response to questioning about whether "the assailant's blood might be on there," Detective Hughes further testified that "I don't have any idea whose blood it is," and thus, "anything's possible." 84

Consequently, Mr. Webster respectfully requests a Y-STR DNA analysis⁸⁵ of all remaining physical evidence from the crime scene that may definitively indicate that his brother Kenneth Neal was the real perpetrator.

B. Lakeeta Smith—Second Eyewitness

At least one other eyewitness—Ms. Lakeeta Smith—witnessed the assault as well. During her interview with Detective Pat Postiglione, Lakeeta Smith told Detective Postiglione that "she was present at 169 Old Hermitage Avenue when the two suspects came by and confronted the victim." Although Ms. Smith provides a description of the suspects, there is no indication in Detective Postiglione's report that Ms. Smith was ever shown a photo lineup or asked to make an identification in this case. Consequently, Mr.

Webster requests that Ms. Smith be located, re-interviewed, and asked to attempt an identification of the perpetrators.

C. Pager/Re-Interviewing Ms. Nelson

Tammy Nelson testified that the perpetrators gave their pager number out to multiple people, ⁸⁷ including "a girl named Tasha Odom" and "[a]nother girl we used to call Big Shanda." ⁸⁸ Before Mr. Webster's trial, Ms. Nelson also told Mr. Webster's investigator that "[w]hen they gave me the phone number - this girl . . . we used to call her Shorty – that's another witness. We went two doors down and I called." ⁸⁹ In total, Ms. Nelson testified that "about three or four other people" were at her house when the perpetrators distributed their pager number. ⁹⁰ It is not clear who these individuals are or whether any of them was ever interviewed prior to Mr. Webster's trial. However, because Tammy Nelson "told Detective Postiglione about those names" while the investigation was underway, they should be contained somewhere in the case file. ⁹¹ With this and other discrepancies in her testimony in mind, this office should also re-interview Ms. Nelson for the purpose of evaluating whether her original identification of Mr. Webster or her subsequent identifications of Mr. Webster's brother is more reliable.

Conclusion

For the foregoing reasons, the investigation into Mr. Leroy Owens' murder should be reopened, and further investigation should be conducted in accordance with the specific requests set forth above.

I. Case History

On March 1, 2017, Joseph Webster filed a Conviction Review Request with the Office of the Davidson County District Attorney General. The request observed, *inter alia*, that:

- 1. The only witness who ever identified Mr. Webster as a perpetrator recanted her identification under oath multiple times;
- 2. The only witness who ever identified Mr. Webster as a perpetrator gave materially conflicting statements before and during trial, provided testimony that conflicted with other witnesses' accounts, provided identification testimony that did not match Mr. Webster's features, and lied repeatedly during the investigation;
- 3. The only witness who ever identified Mr. Webster as a perpetrator concealed her own involvement in the victim's murder and actively obstructed the investigation into it;
- 4. The investigation into Leroy Owens' murder was seriously deficient in multiple respects, it remains a cold case to this day, and the MNPD has never even developed a suspect as to the second perpetrator who was involved;
- 5. Multiple family members have come forward to identify Mr. Webster's half-brother, Mr. Kenny Neal, as the actual perpetrator;
- 6. Significant avenues for additional investigation, including but not limited to DNA testing of the murder weapon and interviewing additional witnesses, remained unexplored; and
- 7. No explanation has ever been provided as to why seven years elapsed between Mr. Owens' murder and Mr. Webster's indictment.

II. First Supplementation

In the time since filing his Conviction Review Request, Mr. Webster has conducted extensive additional investigation regarding his case, either independently or in conjunction with the District Attorney's office. The additional evidence obtained through that investigation has been uniformly exculpatory. That supplemental evidence includes, but is not limited to, the following:

- 1. DNA testing of the murder weapon that excludes Mr. Webster as a contributor of the DNA found on the murder weapon (**Exhibit A**);
- 2. Sworn testimony from Shawanna Norman, an additional, third-party witness to whom Mr. Neal affirmatively confessed, who attempted to report her knowledge to the District Attorney's office, and who recalls myriad additional, critical details that exculpate Mr. Webster, including, but not limited to, providing an explanation as to why the white station wagon would have been spotted outside of Mr. Webster's exwife's home (specifically, that Mr. Neal often drove it when he came to visit Ms. Norman) (**Exhibit B**);
- 3. Evidence that Mr. Neal drove a Green Ford Explorer identified by the central witness in this case at the time of the murder (**Exhibit C-1, C-2, and C-3**); and
- 4. Extensive additional evidence indicating that potentially exculpatory evidence, including the victim's testable clothing, was destroyed prior to Mr. Webster's indicating that additional witnesses and witness statements were not adequately disclosed to Mr. Webster prior to, during, or after trial; and indicating further that the investigation into Mr. Owens' murder was seriously deficient.

- 8 MS. SHAWANNA NORMAN: Chased him. He just told me
- 9 that he chased the dude down and beat him -- beat him with a
- 10 brick, beat the shit out of him with a brick.
- MR. KENNY DYER: Wow. And you don't remember if
- 12 he was there with you the night before he told you that?
- MS. SHAWANNA NORMAN: That's the thing, the night
- 14 that he told me that he was at my -- my granny' house.
- MR. KENNY DYER: Okay.
- 16 MS. SHAWANNA NORMAN: But I don't -- I don't know
- 17 when the boy--
- MR. KENNY DYER: Well--
- 19 MS. SHAWANNA NORMAN: -- actually died because we
- 20 didn't watch the news and stuff.
- MR. KENNY DYER: Yeah, he--
- MS. SHAWANNA NORMAN: It wasn't until-
- MR. KENNY DYER: He -- he died right there.
- MS. SHAWANNA NORMAN: Oh.
- 25 MR. KENNY DYER: Right there at that -- when they

- 1 -- when he (Unintelligible)--
- MS. SHAWANNA NORMAN: (Unintelligible) and
- 3 (Unintelligible) it's a small world because his sister was
- 4 -- the boy who got killed, his sister was doing my hair.
- 5 And then after the trial I couldn't go to her no more to get
- 6 my hair done because she thought that my brother-in-law was
- 7 a murderer. So...
- 8 MR. KENNY DYER: Yeah, that -- that would
- 9 strain the relationship--
- MS. SHAWANNA NORMAN: Yeah.
- 11 MR. KENNY DYER: -- a little bit.
- MS. SHAWANNA NORMAN: Yeah, so... It's like a --
- 13 it's just a series of unfortunate events.
- MR. KENNY DYER: So the police ever come and talk
- 15 you to?
- MS. SHAWANNA NORMAN: No.
- 17 MR. KENNY DYER: When they came and talked to
- 18 Joseph or your sister--
- 19 MS. SHAWANNA NORMAN: No, they didn't talk to me.
- MR. KENNY DYER: But they talked to her?
- MS. SHAWANNA NORMAN: Yep.
- MR. KENNY DYER: Were you--
- MS. SHAWANNA NORMAN: They--
- MR. KENNY DYER: Were you there at the house when
- 25 they talked to--

1 MS. SHAWANNA NORMAN: I was in the living room.
```

- 2 They talked to her right at the front door. That's why I
- 3 said, they never even--
- 4 MR. KENNY DYER: So they didn't come in and sit
- 5 down and talk to her?
- 6 MS. SHAWANNA NORMAN: Uh-huh. They talked to her
- 7 at the front door.
- 8 MR. KENNY DYER: Did they take her to the station?
- 9 MS. SHAWANNA NORMAN: No.
- MR. KENNY DYER: No.
- MS. SHAWANNA NORMAN: Huh-uh.
- MR. KENNY DYER: How long did they stay with her?
- 13 MS. SHAWANNA NORMAN: It was brief -- a brief
- 14 interaction. That's why I was like -- and I think that's
- 15 when they saw the -- the tatoo on her neck, that's how they
- 16 got Joseph in their crosshairs or whatever. I don't-
- 17 MR. KENNY DYER: Because she had his name tatooed
- 18 on her neck.
- 19 MS. SHAWANNA NORMAN: Yes. She had his name
- 20 tatooed on her neck. But -- and they found out that -- I
- 21 think they said in court that she had gotten a ticket in a
- 22 car that was registered to Joseph Webster.
- MR. KENNY DYER: Was that car registered to --
- 24 well, I don't know if they did or not. But if she'd got it
- 25 -- the station was wagon wasn't registered to Joseph?

1 MS. SHAWANNA NORMAN: No, no. But Kenny -- that's
```

- 2 the thing, Kenny was smart. He was -- like when I would go
- 3 with him when he was dropping off packs and stuff for
- 4 people, the drugs he was dropping off, he told -- he used to
- 5 tell people -- when they would address him they would
- 6 address him as "Joe." They wouldn't address him as "Kenny."
- 7 MR. KENNY DYER: Why would they do that?
- 8 MS. SHAWANNA NORMAN: Because he -- he -- he was
- 9 either Joe or James.
- MR. KENNY DYER: He didn't go by his name.
- MS. SHAWANNA NORMAN: He didn't go by his name.
- 12 He didn't use his name with the people.
- MR. KENNY DYER: Wow.
- MS. SHAWANNA NORMAN: So--
- MR. KENNY DYER: Well, when the police were there
- 16 talking to your sister -- what is your sister's name?
- MS. SHAWANNA NORMAN: Katrina.
- 18 MR. KENNY DYER: When they were there talking to
- 19 -- to -- to Katrina -- now is she still -- she's not married
- 20 to Joseph anymore, is she?
- MS. SHAWANNA NORMAN: No, they're divorced now.
- 22 MR. KENNY DYER: They're -- they're divorced.
- When they were there talking to Katrina, did they
- 24 see you, the police?
- 25 MS. SHAWANNA NORMAN: I don't know. I don't-

```
1 MR. KENNY DYER: But they didn't talk you to?
```

- MS. SHAWANNA NORMAN: No. They didn't talk to me.
- 3 I've never spoken to the police about this case at all.
- 4 MR. KENNY DYER: Wow.
- 5 MS. SHAWANNA NORMAN: Never. And I--
- 6 MR. KENNY DYER: So -- so they didn't have your
- 7 information. And when you took the stand, you took the
- 8 stand on the path -- on the behalf of defense, on Joseph's
- 9 part, the -- so Joseph's -- or -- yeah, Joseph's attorney
- 10 called you to the stand?
- MS. SHAWANNA NORMAN: No.
- MR. KENNY DYER: Who called you to the stand?
- MS. SHAWANNA NORMAN: Nobody.
- MR. KENNY DYER: You -- did you ever take the
- 15 stand?
- MS. SHAWANNA NORMAN: No.
- 17 MR. KENNY DYER: You never testified?
- MS. SHAWANNA NORMAN: No.
- MR. KENNY DYER: Okay.
- 20 MS. SHAWANNA NORMAN: I -- I didn't testify. If I
- 21 did, I don't remember testifying.
- MR. KENNY DYER: Okay. I don't know.
- MS. SHAWANNA NORMAN: No, I think that was in like
- 24 -- the trial was in, I think, 2005?
- MR. KENNY DYER: Yeah, I think so.

1 MS. SHAWANNA NORMAN: I think 2005. I don't think

- 2 I testified.
- 3 MR. KENNY DYER: Okay.
- 4 MS. SHAWANNA NORMAN: Nope. I was just -- I was
- 5 just (Unintelligible) --
- 6 MR. KENNY DYER: Have you ever talked to the
- 7 police about this murder?
- 8 MS. SHAWANNA NORMAN: Huh-uh. I ain't talked to
- 9 the police about this murder or nothing else that done
- 10 happened.
- MR. KENNY DYER: And you know about this murder,
- 12 and you know about a murder in Atlanta. How many more you
- 13 know about?
- MS. SHAWANNA NORMAN: Oh, that's it. Well, you
- 15 know, the person that would know more would -- might be
- 16 their other brother Arthur.
- 17 MR. KENNY DYER: Is he still alive?
- 18 MS. SHAWANNA NORMAN: Yes. And don't -- don't
- 19 judge me, but I -- I messed with Arthur after I've done
- 20 messed with Kenny.
- 21 MR. KENNY DYER: I'm ain't here to judge you.
- 22 So you saw Mr. Neal after the murder. How long
- 23 did you mess with him after the murder?
- MS. SHAWANNA NORMAN: It was probably a couple
- 25 months, about a couple months.

1 MR. KENNY DYER: You -- so you messed with him a

- 2 couple months after the murder?
- 3 MS. SHAWANNA NORMAN: Yeah.
- 4 MR. KENNY DYER: Then y'all split?
- 5 MS. SHAWANNA NORMAN: Yeah.
- 6 MR. KENNY DYER: And you--
- 7 MS. SHAWANNA NORMAN: We called -- we wasn't
- 8 really in like a--
- 9 MR. KENNY DYER: A relationship.
- 10 MS. SHAWANNA NORMAN: -- a committed relationship,
- 11 no.
- 12 MR. KENNY DYER: It--
- MS. SHAWANNA NORMAN: It was just like an off an
- 14 on thing, yeah.
- MR. KENNY DYER: Okay. Okay.
- And so after the trial is when you tried to go
- 17 down and -- and record?
- MS. SHAWANNA NORMAN: Yeah, yeah.
- 19 MR. KENNY DYER: So that would have been 2005?
- MS. SHAWANNA NORMAN: Yeah, because I figured--
- 21 MR. KENNY DYER: So that's years after.
- 22 MS. SHAWANNA NORMAN: Yeah. Because I figured --
- 23 we figured at the -- at the trial, we -- when -- when it
- 24 came up, we was like why did they deny Joseph parole except
- 25 for a cold case for a murder? You know what I'm saying?

1 MR. KENNY DYER: Yeah, he was in on drugs, drug

- 2 charges.
- MS. SHAWANNA NORMAN: Yeah, he was on drug charges
- 4 where his cousin's -- his cousin's boyfriend had set him up.
- 5 MR. KENNY DYER: Okay.
- 6 MS. SHAWANNA NORMAN: And--
- 7 MR. KENNY DYER: So you're just saying you only
- 8 saw Mr. Neal for maybe a month or two or three or four? Or
- 9 how long you think you saw him after the murder?
- 10 MS. SHAWANNA NORMAN: Well, I -- well, you know, I
- 11 wasn't messing with him, but I saw him all the time.
- 12 MR. KENNY DYER: Right.
- MS. SHAWANNA NORMAN: Yeah, I just wasn't messing
- 14 with him.
- MR. KENNY DYER: Okay. So did you ever see him
- 16 driving station wagon again after that murder? Or when did
- 17 they--
- 18 MS. SHAWANNA NORMAN: I -- I -- this is what --
- 19 from -- and I got that they took the station wagon and
- 20 burned it up from Kenny. That's where that came from. That
- 21 ain't something that I just--
- MR. KENNY DYER: Kenny told you that?
- MS. SHAWANNA NORMAN: Yeah.
- 24 MR. KENNY DYER: Not -- not Phillip Cotton?
- MS. SHAWANNA NORMAN: No, no, no. Like, I -- I

- 1 probably never even -- I might have, you know, spoke to
- 2 Phillip -- Phil -- Phil, or whatever. But as far as
- 3 carrying on a conversation and all that, I didn't do all of
- 4 that.
- 5 MR. KENNY DYER: Right.
- 6 MS. SHAWANNA NORMAN: Like if we was all in the
- 7 car together and he would be on the back seat or whatever,
- 8 but yet we didn't -- we didn't socialize like that.
- 9 MR. KENNY DYER: Do you know who might have been
- 10 with Kenny when this murder took place where he beat this
- 11 boy with a brick?
- 12 MS. SHAWANNA NORMAN: Phil.
- MR. KENNY DYER: Phillip?
- MS. SHAWANNA NORMAN: Yeah, Phil. Because when he
- 15 came -- when he told me that he had to chase the dude down
- 16 and beat the shit out of him with a brick, Phil was with him
- when he came to my granny' house.
- 18 MR. KENNY DYER: Who would have been driving the
- 19 car? Phillip or -- or--
- 20 MS. SHAWANNA NORMAN: I--
- 21 MR. KENNY DYER: -- or Kenny?
- MS. SHAWANNA NORMAN: I think Kenny was driving
- 23 the car.
- MR. KENNY DYER: Okay. You think, you don't know
- 25 for sure?

1 MS. SHAWANNA NORMAN: It's Kenny's car. I mean,
```

- 2 Phillip didn't -- well, Phil didn't never drive, so...
- 3 MR. KENNY DYER: Okay.
- 4 MS. SHAWANNA NORMAN: He was always on the
- 5 passenger side, so...
- 6 MR. KENNY DYER: Were they both pretty much the
- 7 same size? Were they--
- MS. SHAWANNA NORMAN: They was pretty -- pretty
- 9 much the same height -- yeah, pretty much the same size.
- 10 And that's why the -- the description that they gave
- 11 in court was Kenny. Like it -- I -- I just don't -- I don't
- 12 understand how the legal system works. You know, I -- I
- 13 have been in trouble before. And I just -- justice isn't
- 14 for everyone, everybody does not receive justice. And it's
- 15 easy for me to say that -- for me to sit on the phone --
- 16 like I used to try to write letters to churches and stuff
- 17 and see if they would help Joseph. I even wrote a letter to
- 18 the president, because I knew that he was innocent.
- 19 MR. KENNY DYER: Right.
- MS. SHAWANNA NORMAN: But it's easy for me because
- 21 I'm out free to tell him, you know, "Keep the faith, God
- 22 wouldn't have you there"--
- MR. KENNY DYER: Yeah, yeah. He wouldn't-
- MS. SHAWANNA NORMAN: -- "for stuff you didn't
- 25 do."

1 MR. KENNY DYER: Yeah. "He won't -- he won't

- 2 leave you, he won't abandon you," and...
- 3 MS. SHAWANNA NORMAN: Yeah. And I'm not the one
- 4 serving time. I'm not the one being told when to wake up,
- 5 when to eat. You know what I'm saying? So...
- 6 MR. KENNY DYER: When was -- when was the last
- 7 time you saw Kenny Neal?
- 8 MS. SHAWANNA NORMAN: Probably 2000 and -- between
- 9 2010, 2013.
- 10 MR. KENNY DYER: 2010, 2013?
- MS. SHAWANNA NORMAN: Yeah.
- MR. KENNY DYER: Do you remember where you saw
- 13 him, or what the circumstances were or--
- MS. SHAWANNA NORMAN: I think he was at a gas
- 15 station. Because I -- I had to -- they foreclosed on my
- 16 house in October Woods. And he was at a gas station, I
- 17 think the gas station, the TA, which is up the street.
- 18 MR. KENNY DYER: Okay.
- 19 MS. SHAWANNA NORMAN: And later I found out that
- 20 him and his girlfriend bought a house up the street from me.
- 21 It's like, you know, Old Hickory Boulevard. You know where
- 22 October Woods is?
- MR. KENNY DYER: Yeah.
- MS. SHAWANNA NORMAN: Yeah, I was living in
- October Woods. And I think Ms. Marie, that's their mama,

1 she said that he bought a house out here. So...
```

- 2 MR. KENNY DYER: So he lives out here somewhere?
- 3 MS. SHAWANNA NORMAN: Yeah. That was then--
- 4 MR. KENNY DYER: Okay.
- 5 MS. SHAWANNA NORMAN: -- I don't know if he still
- 6 -- they still--
- 7 MR. KENNY DYER: Okay.
- 8 MS. SHAWANNA NORMAN: -- because he goes through
- 9 women like--
- 10 MR. KENNY DYER: Were you ever afraid of him?
- MS. SHAWANNA NORMAN: Yeah, yeah, yeah. I -- I --
- 12 I didn't get to tell you, like we would be at their house,
- 13 and that they would be having a cookout for everybody. And
- 14 he would turn the stove on high, the eye on high. And if --
- 15 his wife could have did anything--
- MR. KENNY DYER: Yeah.
- MS. SHAWANNA NORMAN: -- it could be something
- 18 small, he would tell her to sit on the eye, and she'd do it.
- 19 It -- it was just like -- it was crazy. She--
- MR. KENNY DYER: Sit on the flame?
- 21 MS. SHAWANNA NORMAN: It -- it wouldn't be the
- 22 flame. It would be--
- MR. KENNY DYER: Oh, you're talking about the
- 24 electric stove?
- MS. SHAWANNA NORMAN: The -- it would be the --

- 1 the--
- 2 MR. KENNY DYER: Yeah.
- 3 MS. SHAWANNA NORMAN: -- the yeah, the unit, yeah.
- 4 He -- he -- he used to do stuff like that in front of us to
- 5 -- I guess -- I think it was to make us fear him. You know,
- 6 the stuff he used to do is like something with -- somebody
- 7 with a conscience wouldn't do.
- 8 MR. KENNY DYER: Wow.
- 9 MS. SHAWANNA NORMAN: And I -- if anybody else
- 10 would sass me -- if he told me anybody else -- because I --
- 11 I'm pretty sure that he -- he -- he knows -- you know what
- 12 I'm saying -- he knew that he killed a boy. He didn't tell
- 13 me that he killed him; he told me that he had to beat the
- 14 shit -- chase him and put -- beat the shit out of him with a
- 15 brick. But if anybody else knows besides me, it's Tracy.
- MR. KENNY DYER: Tracy is his--
- 17 MS. SHAWANNA NORMAN: His wife at the time.
- 18 MR. KENNY DYER: Not still, though?
- MS. SHAWANNA NORMAN: No, not now.
- 20 MR. KENNY DYER: Well, do you know Tracy's last
- 21 name?
- 22 MS. SHAWANNA NORMAN: I don't know what her -- her
- 23 maiden name is. I can try to check into it for you.
- MR. KENNY DYER: I can probably find it. Do you
- 25 know her?

1 MS. SHAWANNA NORMAN: I did. We did hang out. We

- 2 used to go to the clubs and that but--
- 3 MR. KENNY DYER: Do you think she'd -- do you
- 4 think she'd talk about this?
- 5 MS. SHAWANNA NORMAN: Me and Tracy were going to
- 6 this guy named -- they called Sissy Willie (phonetic) -- he
- 7 do hair -- to get our hair done. This -- a lot of stuff
- 8 happened around getting hair done. And I had asked Willie,
- 9 I was like, "Can you please have Tracy call me?" This is
- 10 after the trial, after everything. This is probably four or
- 11 five years ago. And she called me. And then I gave Joseph
- 12 her number so he could call her. And she said she didn't
- 13 want anything to do with it.
- MR. KENNY DYER: Okay.
- MS. SHAWANNA NORMAN: So -- but I'm -- I'm telling
- 16 you that if -- if everybody knows any -- knows about
- 17 anything else that Kenny has done, Tracy knows. She used to
- 18 -- she was like deathly afraid of him.
- 19 MR. KENNY DYER: Are you afraid of him now?
- MS. SHAWANNA NORMAN: I used to -- I used to be.
- 21 But now, I -- I have -- my boyfriend is here, and I don't
- 22 think there's really too much that he can do to me.
- MR. KENNY DYER: Uh-huh.
- MS. SHAWANNA NORMAN: But like the -- the threats
- 25 he used to make, and I seen the stuff he used to do

- 1 firsthand, it -- it was like he -- he don't have a
- 2 conscience, so like what's to keep him from doing something
- 3 to us? Like when he first told me that he -- "I'll kill you
- 4 bitch" -- like, "bitch, if you're done trying to -- trying
- 5 to set me up..." So me and my sister was like scared. We
- 6 was like, "Kenny -- Kenny going to kill-- going to do
- 7 something to us."
- 8 MR. KENNY DYER: Wow. But you never did go to the
- 9 police with any of this information?
- 10 MS. SHAWANNA NORMAN: No. And they never even,
- 11 you know, asked to speak with me. Like it was--
- MR. KENNY DYER: And after all these years, why
- 13 are you talking to me about it now?
- MS. SHAWANNA NORMAN: Because you called me.
- MR. KENNY DYER: Okay.
- 16 MS. SHAWANNA NORMAN: If you hadn't called I still
- 17 wouldn't have been talking to nobody about it.
- MR. KENNY DYER: You wouldn't -- it would have
- 19 been what it was?
- MS. SHAWANNA NORMAN: Yeah. I mean--
- MR. KENNY DYER: Well, let me -- are you willing
- 22 to talk to the police or the district attorney and then tell
- 23 them what you're telling me now?
- MS. SHAWANNA NORMAN: Yeah, I'll talk to them.
- 25 And the other person that -- that knows that Kenny

1 is the devil in -- in human form is their mama. Ms. Marie

- 2 know the stuff Kenny do. She knew -- she knew Kenny killed
- 3 that boy. She -- she -- she knows what's going on. And she
- 4 -- she just -- she -- she was like, "I've already lost
- 5 Joseph, I don't want to lose Kenny too." I'm like, "For
- 6 real? You know your older son got your younger son in
- 7 prison"--
- 8 MR. KENNY DYER: Doing time for what he--
- 9 MS. SHAWANNA NORMAN: -- "for something that he --
- 10 that he didn't do."
- And that's why I was like, all you got to do is go
- 12 back -- they can talk to Mickey. Mickey know that Kenny
- 13 agreed to pay him. Kenny agreed to pay him for the Joseph's
- 14 defense, because everybody's thinking there's no way he
- 15 could be found guilty because he's innocent. And you -- you
- 16 -- like -- that just blows my mind. And then like, come to
- 17 find out, the woman whose house the boy was at, the woman
- 18 who text Kenny--
- MR. KENNY DYER: Yeah.
- 20 MS. SHAWANNA NORMAN: -- or -- or beeped him to
- 21 tell him to come up here, she used to mess with my daddy.
- 22 Tammy -- Tammy Nelson--
- MR. KENNY DYER: Uh-huh.
- MS. SHAWANNA NORMAN: -- she used to go with my
- 25 daddy. And that's-

1 MR. KENNY DYER: So she knows -- she knows who --

- 2 does she -- she know who Kenny--
- 3 MS. SHAWANNA NORMAN: She didn't -- she didn't
- 4 know who Joseph was. She thought Kenny was -- she -- Kenny
- 5 told her his name was Joe.
- 6 MR. KENNY DYER: Okay.
- 7 MS. SHAWANNA NORMAN: That's where she got the
- 8 name Joe from.
- 9 MR. KENNY DYER: All right. So if the police and
- 10 the invest -- and the -- and the district
- 11 attorney, you -- you're willing to cooperate with them and--
- MS. SHAWANNA NORMAN: Yeah.
- MR. KENNY DYER: Okan. And you'll swear under
- 14 oath?
- 15 MS. SHAWANNA NORMAN: Yeah.
- MR. KENNY DYER: I'm going -- what I'm going to do
- 17 is I'm going to take this interview--
- MS. SHAWANNA NORMAN: Okay.
- 19 MR. KENNY DYER: -- and reduce it to writing.
- MS. SHAWANNA NORMAN: Okay.
- MR. KENNY DYER: And--
- MS. SHAWANNA NORMAN: Going to transcribe it.
- MR. KENNY DYER: And transcribe it. It'll be a
- 24 statement--
- MS. SHAWANNA NORMAN: Okay.

- 1 MR. KENNY DYER: -- your statement-
- MS. SHAWANNA NORMAN: Okay.
- 3 MR. KENNY DYER: -- as it pertains to this
- 4 incident. And then I may come back out to you and have you
- 5 sign and swear that -- that it's your statement.
- 6 MS. SHAWANNA NORMAN: That's fine. That's fine.
- 7 I just -- I don't-
- 8 MR. KENNY DYER: And you're willing to go to court
- 9 if it ever gets back to it?
- 10 MS. SHAWANNA NORMAN: I would have went to court
- 11 back then. They just never asked me. Mickey never asked
- 12 me.
- MR. KENNY DYER: Okay. That's...
- So we know about a murder in Atlanta. We know
- 15 about this murder. And he told you that he chased a dude
- 16 down and hit him with a brick.
- 17 MS. SHAWANNA NORMAN: Yep. And he beat the shit
- 18 out of him with a brick.
- MR. KENNY DYER: Over?
- MS. SHAWANNA NORMAN: Because he owed him money,
- 21 for he had gave him a pack and then he ran off, so...
- MR. KENNY DYER: And didn't -- and didn't pay for
- 23 it.
- MS. SHAWANNA NORMAN: No, he didn't pay for it.
- MR. KENNY DYER: Oh, he paid for it.

1 MS. SHAWANNA NORMAN: Oh, yeah, with his life,

- 2 but--
- 3 MR. KENNY DYER: With his life.
- 4 MS. SHAWANNA NORMAN: -- that's unfortunate.
- 5 MR. KENNY DYER: Didn't pay cash.
- 6 MS. SHAWANNA NORMAN: It -- it wasn't that
- 7 serious, though.
- 8 MR. KENNY DYER: No.
- 9 MS. SHAWANNA NORMAN: So...
- 10 MR. KENNY DYER: How big of a drug dealer was
- 11 Kenny Neal?
- 12 MS. SHAWANNA NORMAN: He -- I mean, he had a
- 13 little weight. He had a little weight. So...
- MR. KENNY DYER: And was Joseph dealing with him
- 15 too?
- MS. SHAWANNA NORMAN: Not with him. Joseph stayed
- on the east side of town. That's the thing, my sister used
- 18 to catch cabs and stuff out east with Joseph. Joseph really
- 19 didn't fool around down south unless he came to my granny'
- 20 house.
- 21 MR. KENNY DYER: So Kenny--
- MS. SHAWANNA NORMAN: Kenny was the one fooling
- 23 around. And Kenny like -- I used to go to a house in Vine
- 24 Hill with Kenny -- you know, Vine Hill is in south
